## Carlisle Spray Foam Insulation STANDARD LIMITED PRODUCT WARRANTY

Carlisle Spray Foam Insulation (CSFI) warrants that SealTite PRO spray polyurethane foam insulation products will be free from manufacturing defects which affect the ability of the Product to perform in conformance with the product label and technical data sheet for its intended application during the life of the building. CSFI will replace at no charge any Product proved to be defective, provided it has been applied in accordance with our written application instructions for uses we recommended as suitable for this Product, installed by an authorized CSFI applicator, and a completed warranty registration form. This warranty extends to subsequent property owners upon written notice to CSFI, and providing that the building use remains the same.

CSFI's sole responsibility under this warranty will be for the replacement of Products only. CSFI will not be liable for any labor or other costs, including, but not limited to, costs associated with the removal of insulation or the installation of replacement Products.

A spray foam insulation contractor who installs the Product is not a representative, agent or employee of CSFI or Carlisle Weatherproofing Technologies (CWT). CSFI therefore is not bound by any representations made by the contractor and/or installer and does not warrant or guarantee the contractor's and/or installer's workmanship.

CSFI will have no liability for defects, damages, or failures caused by improper storage of Products, improper application of Products, including failure to follow CSFI published application guidelines, fire, weather, floods, acts of God, abuse, structural failures, breaks, movement, or penetrations or alterations made after installation of the Products.

To make a warranty claim, purchaser must notify CSFI through email at Warranty@carlislesfi.com, within seven (7) business days of discovery of any product defect claim. The purchaser must give written notice to CSFI no later than thirty (30) days after a product defect is discovered or should by reasonable diligence have been discovered. The notice shall include all information available from the purchaser regarding the nature and source of the warranted claim. Proof of installed product purchase must be provided with the written notice. When properly and timely notified as described, CSFI reserves the right to inspect and test the product and if any defect covered by the terms of this Warranty are found, will arrange for replacement of the quantity of product affected by defect. Repair and the cost thereof, of all other non-warranted claims are the responsibility of the purchaser.
